
Following documents are to be produced by the candidate in original along with two sets photocopy (Self-attested):

2. Filled in Application Form in Original
3. Downloaded copy of NEET ADMIT CARD
4. Downloaded copy of NEET CONFIRMATION PAGE
5. Downloaded copy of NEET RESULT
6. Photo Identity Card issued by the respective state Govt. /Govt. of India. (Example: Voter Card, Aadhar Card etc.)
7. Affidavits/Bond in original and one set photocopy
 - (i) Notorised Bond of ₹ 50,000/- (Rupees Fifty Thousand Only) on Non-Judicial Stamp paper of ₹ 100/- as per prospectus.
8. Certificate/Testimonials (in original along with two sets self-attested Photocopy)
 - I. 10th Standard Admit Card, Mark Sheet, Passing Certificate
 - II. 12th Standard Admit Card, Mark Sheet, Passing Certificate
 - III. Caste Certificate (as per the prospectus in case of ST/SC/OBC candidates)

Authority reserves the right to modify the provisional lists of candidates called for counseling or the notice of counselling.

Candidates who will appear on wrong date of counselling or remain absent on the date of counselling or fail to submit the required document, their candidature will be cancelled and the next candidate in merit shall be considered for admission.

Admission to 5½ years BHMS course, session 2018 – 2019, batch 30th shall be made only after getting necessary permission from the Ministry of AYUSH, Govt. of India.
