That the National Institute of Homoeopathy, Kolkata have not violated any of the provisions of any of the statutes/guidelines of any statutory authority in the period of five years preceding the date of submission of the application seeking status of a National Institute of Homoeopathy, Kolkata, Deemed to be University.

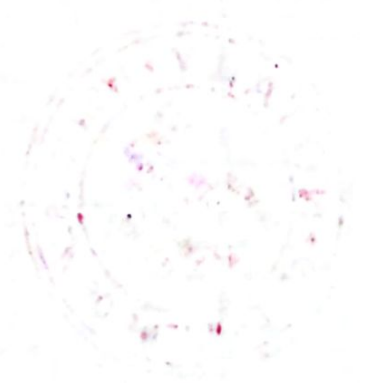

4. That hostel accommodation shall be gradually increased to at least 25% of the students within three years of existence of Institution Deemed to be University.
5. That the Corpus Fund irrevocable in nature and shall not be liquidated without prior permission of the Commission and interest accrued on the Corpus Fund shall be used only for the purpose of development of the National Institute of Homeopathy, Kolkata Deemed to be University.
6. That from we undertake to submit undertaking from the funding society i.e. Ministry of AYUSH, Govt. of India to the effect that on being declared as National Institute of Homoeopathy, Kolkata Deemed to be University, the National Institute of Homeopathy, Kolkata shall continue to receive the funds for maintenance and developmental expenditure, including the salary and non-salary increases in expenditure and the future expansion.
7. That on being declared as National Institute Homoeopathy, Kolkata Deemed to be University under the UGC Act., the National Institute of Homoeopathy, Kolkata shall admit students to its approved academic programmes, under its enrolment, only from the academic session subsequent to the notification issued by Central Govt. and enrolment of students to the National Institute of Homeopathy, Kolkata, for any reason whatsoever, in anticipation of the declaration as a National Institute of Homoeopathy, Kolkata Deemed to be University or inclusion of the National Institute of Homoeopathy, Kolkata under the ambit of a National Institute of Homoeopathy, Kolkata Deemed to be University, shall render the application invalid.
8. That the income and property of National Institute of Homoeopathy, Kolkata howsoever derived, shall be utilized only for the promotion of the objectives of National Institute of Homeopathy, Kolkata including its growth and development. No portion of the income/ property of the National Institute of Homoeopathy, Kolkata shall be paid or transferred, directly or indirectly by way of profit, to the person who were/ are Members of the National Institute of Homeopathy, Kolkata provided that nothing herein contained shall prevent the payment in good faith or remuneration to any Member thereof or to any other person in

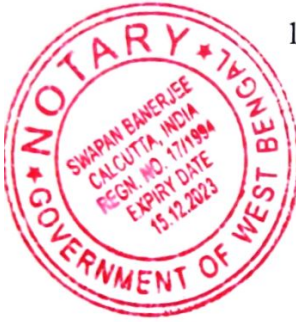

return of any service rendered to the National Institute of Homoeopathy, Kolkata or for travelling, halting and other similar charges and all such expenditure shall be appropriately reflected in the Accounts of National Institute of Homoeopathy, Kolkata maintained for the purpose.

9. That the professional programmes already being conducted by it, if any, have the approval of the relevant statutory/ regulatory bodies like AICTE, MCI, DCI, NCTE, BCI, INC, etc. along with a duly attested copy of the letter of approval granted to it by such bodies. In addition, each application shall be accompanied by an essentiality certificate from the State Govt. concerned wherever necessary.
10. That after declaration of National Institute of Homeopathy, Kolkata as Deemed to be University, it shall not use the word 'University' suffix to its name but may mention the word "Deemed to be University" within parenthesis suffixed thereto.
11. That the land and other assets of the National Institute of Homoeopathy, Kolkata shall be transferred legally by it to the Deemed to be University within one year of notification declaring the National Institute of Homoeopathy Kolkata as Deemed to be University.
