Scope of Consultancies/Responsibilities:

Leave:

Paid leave of absence may be allowed @ 1.5 days for each completed month of service. Accumulation of leave beyond a calendar year will not be allowed.

Working hours:

- The Contractual Teachers shall be required to observe the normal office timing from Monday to Saturday and may also be called upon to attend the office on Sunday or any holiday in case of urgency.
- They shall mark their attendance in AEBAS mandatorily, failing which it may result in deduction of remuneration.

Tax Deduction at Source:

The Income Tax or any other Tax will be deducted at source as per Govt. instructions. Necessary TDS Certificate will be issued to them.

Confidentiality of Data and Documents:
