**Essential and minimum Qualification:**

1. MBBS Degree from a recognized University/ Institute included in the First or Second Schedule or Part-II of the Third Schedule of the Indian Medical Council Act, 1956 (102 of 1956) and Medical Council Registration as Medical Practitioner in the Medical Council of India or any other State Medical Council.
2. One (01) year experience in the relevant field in a Govt./ Autonomous Hospital/ Reputed Hospital/ Institution.

1. Not exceeding 50 years as on the date of interview.
